The Ohio Food and Agriculture Clearance Programs provide an extensive, nourishing selection of food to families and individuals who are eligible to receive food through Ohio's emergency food network. Through a statewide partnership with more than 100 Ohio producers, this program recovers surplus and unmarketable agricultural products. The State of Ohio, through ODJFS, provides funding to purchase these products. This program provided over 59.5m lbs of food to Ohio Foodbanks.

The Ohio Association of Foodbanks partners with the Corporation for National and Community Service to carry out national service programming including AmeriCorps VISTA and AmeriCorps VISTA Summer Associates. VISTA members perform a wide variety of activities depending on the program in which they participate. Some of these activities include supporting Summer Food Service Program summer sites. ALL VISTAS contribute to capacity building at the organizations in which they are placed. To date, the Ohio Association of Foodbanks has placed more than 1,427 national service members; those national service members have recruited 44,732 volunteers who have served more than 6.50m summer meals and raised 4.5m in cash and In-Kind donations.
