FEDERAL

<u>Equity Legislation Monitor</u> Developed by The Root Cause Coalition

The Root Cause Coalition has developed an Equity Legislation Monitor, which highlights the development and implementation of policies that address the social determinants of health, lower healthcare costs and improve health outcomes.

This tool was designed to track the relevant legislation on key equity and social determinants of health issues that are introduced in the 118th Congress. The tool includes bills that cover topics of nutrition and food security, rural health, digital equity, environment and climate crisis, gun violence prevention, housing, infant and maternal mortality, and payment models.

Ohio House of Representatives - SNAP Benefit Expansion

On Friday, February 16th, 2024, two bi-partisan members of the Ohio House of Representatives introduced legislation that would provide a minimum monthly SNAP benefit of \$50 to older adults that currently receive less than \$50/month.

A New SNAP Look-Book with Stories from Eight Neighbors Audrey Vanzant, Director of Communications, The Ohio Association of Foodbanks

This project aimed to gather stories about the lived experience of neighbors across Ohio, and asked them to reflect on a year of higher food costs, without extra pandemic SNAP support. This look-book serves as a collection of narratives, featuring firsthand accounts from eight neighbors across the state from all walks of life

What Anti-Hunger Advocates Need to Know About Standardized Screening for Food Insecurity and Other Health Related Social Needs (November 2023) - this brief examines recent standards-setting initiatives within the healthcare sector regarding screening for food insecurity and other health-related social needs. It offers recommendations for anti-hunger advocates to leverage screening efforts to improve the nutrition, health, and well-being of people struggling to put food on the table.

The Rockefeller Foundation to Increase Investment in U.S. Food is Medicine Solutions to \$100 Million (January 2024) - The Rockefeller Foundation announced at the Health and Human Services Food is Medicine Summit that it will invest an additional USD \$80 million over the next five years to advance Food is Medicine Programs in the United States. It also marks the start of a new partnership with the U.S. Department of Health and Human Services (HHS) to accelerate the adoption of Food is Medicine in health systems.

Health Related Social Needs and Whole Person Health: Relationship Between Unmet Social Needs, Health Outcomes, and Healthcare Spending Among Commercially Insured Adults (December 2023) - This study examined the prevalence of health related social needs in commercially insured patients, not just Medicaid and Medicaid enrollees. This study used survey data from Elevance Health commercially insured members residing in Georgia and Indiana. "Of 1,160 commercially insured adults, 76% indicated experiencing 1 or more health related social needs, and 29% reported greater than 3 health related social needs. "Financial wellbeing and healthy food access were individually associated with healthcare spending (Table 3, Panel B). Financial wellbeing was associated with an adjusted average of \$3,323 (95 % CI, \$437.95 - \$6207.89) in additional healthcare spending, and healthy food access was associated with an adjusted average of \$3,950 (95 % CI, \$939.83-\$6,959.94) in additional healthcare spending." (Falconi, et. al 2023)

On Wednesday, January 31st, 2024, the Office of Disease Prevention and Health Promotion (ODPHP) partnered with the Office of Intergovernmental & External Affairs to host the first-ever HHS Food is Medicine summit in Washington, D.C., an all-day event for policy makers, advocates, researchers, and a wide variety of stakeholders with equities in the Food is Medicine space.


