



The Akron-Canton Regional Foodbank serves 563 member agencies in Carroll, Holmes, Medina, Portage, Stark, Summit, Tuscarawas, and Wayne Counties. They are requesting \$2 million toward emergency food and non-food items for distribution to community members in need and \$8 million for infrastructure improvements, equipment to support perishable food distribution, technology upgrades to expand service efficiency, and funding to expand delivery services to areas with limited resources.



The Foodbank, Inc. serves 107 member agencies in Greene, Montgomery, and Preble Counties. They are requesting \$6 million for a building expansion; additional vehicles for transporting and distributing food; a freezer/cooler organization system; investments in their job training program for returning citizens; and capacity building for their member agencies, such as refrigerators, freezers, shelving, etc.



Freestore Foodbank serves 309 member agencies in Adams, Brown, Clermont, Clinton, Hamilton, Highland, Pike, and Scioto Counties. They are requesting \$2 million toward emergency food and non-food items for distribution to community members in need, \$4 million for capacity building for their member agencies, such as refrigerators, freezers, and trucks, and \$4 million for an expansion of their workforce development programs and stabilization services for workforce training program participants.



The Greater Cleveland Food Bank serves 1,128 member agencies in Ashland, Ashtabula, Cuyahoga, Geauga, Lake, and Richland Counties. They are requesting \$10 million toward renovating their former facility into a new food resource center to address the roots causes of hunger and to create two more locations on the west and south sides of their service area.



Mid-Ohio Food Collective serves 673 member agencies in Belmont, Coshocton, Delaware, Fairfield, Fayette, Franklin, Guernsey, Harrison, Jefferson, Knox, Licking, Madison, Marion, Monroe, Morrow, Muskingum, Noble, Pickaway, Ross, and Union Counties. They are requesting \$5 million toward emergency food and non-food items for distribution to community members in need and \$5 million for rural infrastructure development, including investments in hub markets, transportation, refrigeration, and kitchen expansions in outlying counties.



SE Ohio Foodbank & Kitchen serves 63 member agencies in Athens, Gallia, Hocking, Jackson, Lawrence, Meigs, Morgan, Perry, Vinton, and Washington Counties. They are requesting \$802,500 toward emergency food and non-food items for distribution to community members in need and \$4,547,500 to purchase and install a walk-in refrigerator and cooler for a choice pantry to be opened in 2023 and to build service equity in southern, rural counties through acquisition of space or additional capacity for existing partners.



Second Harvest Food Bank of Clark, Champaign, and Logan Counties serves 78 member agencies in Champaign, Clark, and Logan Counties. They are requesting \$10 million toward a desperately needed new building. Their current facility is rapidly deteriorating, lacks stability, safety, and reliability, and cannot be used long-term.



Second Harvest Food Bank of the Mahoning Valley serves 120 member agencies in Columbiana, Mahoning, and Trumbull Counties. They are requesting \$825,000 toward emergency food and non-food items for distribution to community members in need and \$4,675,000 to expand their distribution center to accommodate additional dry goods storage.



Second Harvest Food Bank of North Central Ohio serves 135 member agencies in Crawford, Erie, Huron, and Lorain Counties. They are requesting \$5,350,000 to expand their distribution center to increase dry storage and receiving dock space; build the capacity of key hunger relief partners to store and distribute fresh and frozen foods; establish community hubs to address the root causes of food insecurity; and purchase a refrigerated box truck and a delivery van to provide food to homebound seniors and people with disabilities.



Shared Harvest Foodbank serves 114 member agencies in Butler, Darke, Miami, Preble, and Warren Counties. They are requesting \$747,500 toward emergency food and non-food items for distribution to community members in need and \$5,002,500 to increase efficiency in their warehouse by removing walls and installing racking; install a covered drive-thru for weekly food distributions; purchase trucks for member agencies; and support surge frontline labor costs.



The Toledo Northwestern Ohio Food Bank serves 199 member agencies in Defiance, Fulton, Henry, Lucas, Ottawa, Sandusky, Williams, and Wood Counties. They are requesting \$6,250,000 toward a new warehouse to expand their storage capacity for dry, fresh, and frozen foods.



West Ohio Food Bank serves 82 member agencies in Allen, Auglaize, Hancock, Hardin, Mercer, Paulding, Putnam, Seneca, Shelby, Van Wert, and Wyandot Counties. They are requesting \$1,337,500 toward emergency food and non-food items for distribution to community members in need and \$4,012,500 to purchase refrigerated box trucks, refrigerated trailers, fork lifts, and electric pallet jacks and to convert and repurpose the mezzanine area of their facility from miscellaneous storage to staff usage.
